* General Type Approval

The abZ is the national verification of usability for construction products and will be granted from DIBt (German Institute for Construction Technology) since 1968. With the abZ the manufacturing company will be audited and regulated for the characteristics of the integrity of the product, the areas of use as well as aspects of processing, transport, storage, identification and agreement confirmation. By issuing an abZ it removes the otherwise necessary approval of individual cases.

** Design Certification

The Design Certification replaces the General Building Inspectorate since July 2017 for the approval of (abZ) designs. It can only be applied for at the DIBt. With this new type of process, the planning, dimensioning and execution of designs and construction are regulated.
